If you have a loan at Plus4 Credit Union, you may qualify for our Skip-A-Pay program. If you qualify, the program allows you to skip one monthly loan payment or two bi-weekly payments per calendar year. The processing fee of \$30 per loan per request is required and must be received before your application will be processed.

Not all loans qualify for a Skip-A-Pay: Loans titled CUAC or CUDL (indirect vehicle loans); any real estate, home equity or mortgage loan; or any Share Certificate secured loans are not eligible. In addition, your loan must be aged at least 12 months; all accounts and loans must be current and in good standing with Plus4 Credit Union; and the repayment history must be in good status (no extension or slow payments in the past 12 months). You agree to alter the terms of your original loan agreement and to repay the entire unpaid balance, plus interest, at your current interest rate. If your loan is being repaid through payroll deduction from your employer, the payment due during the month skipped will not be transferred to the loan and will remain in your account.

3. Enclose a personal check for the \$30 fee or check the payment method below.
4. Application and fee must be received at least five (5) days prior to the due date of the payment to be skipped.
